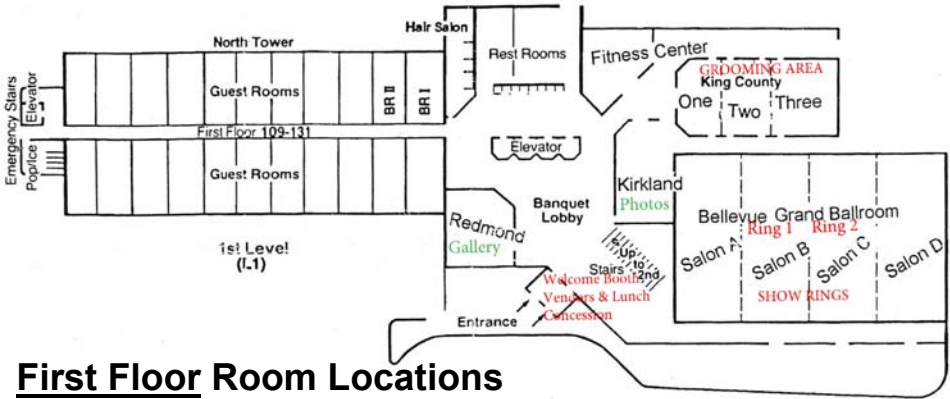

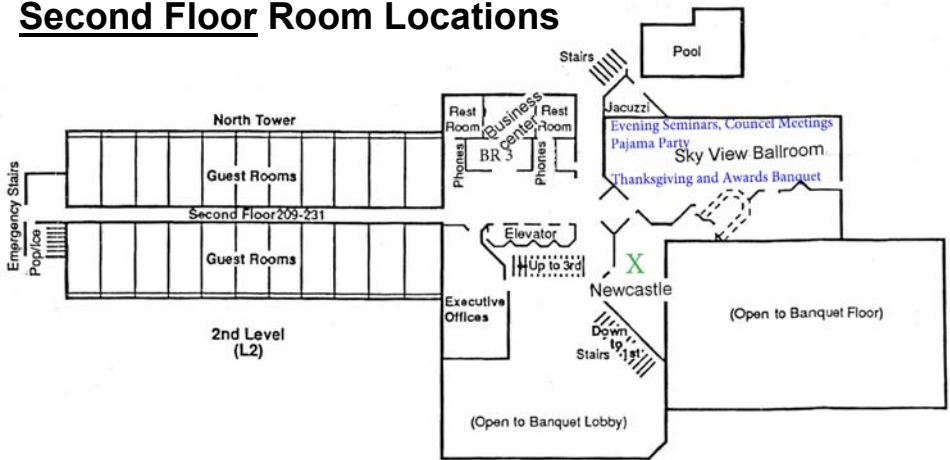

CARE OF THE SHOW SITE

Care for the show site is of utmost importance to the Bulldog Club of America. - The person, or persons, found in violation of the hotel or motel and AKC and BCA rules shall be asked to leave the premises immediately, and
- If suspended from all AKC privileges, the offender's name(s) shall be published in the *AKC Gazette* and *The Bulldogger* as having been found guilty of the said AKC/BCA rules.
