IMPORTANT INFORMATION RELATING TO COVID-19

Mother Lode Bulldog Club of Sacramento and Bulldog Club of Northern California (the "Clubs") will prioritize the health and safety of their members, exhibitors and others in attendance at these specialty shows. As such, the Clubs will enforce social distancing rules and other guidelines implemented by the Governor of California, the State Department of Public Health or other state or local government agencies in response to the Covid-19 pandemic and in force at the time of our shows. These Public Health Guidelines are subject to change at any time and could, under extreme circumstances, require the cancellation of our shows for reasons beyond the Clubs' control.

The Clubs will take actions to mitigate health risks to the best of their ability. The Clubs are pleased to be able to hold our specialty shows OUTDOORS under a very large outdoor area (approx. 20,000 sq. ft.) which will facilitate safe social distancing for exhibitors, spectators, members and our judges. Other precautions may be taken to adhere to Public Health Guidelines, including limiting the number of chairs around the show ring and requesting that attendees try to stay at least 6 ft. apart where possible. Those in attendance will be expected to wear a face covering while in the ring and at any other time they are in the arena and may be in close contact with others outside their immediate family.

The Clubs will ask our judges to allow extra time for exhibitors and their dogs to reach the ring, if necessary, to avoid crowding at ringside. The Clubs will adjust their schedule of events as necessary in response to the public health conditions in place at the time of our shows. There can be no assurance that this will change before the time of our shows. No matter what, it's our intention that everyone enjoy themselves, stay safe and make the best of it in these challenging times. While the Clubs do not, at this time, intend to restrict attendance at the shows, please be mindful of the Public Health Guidelines before you invite friends or other members of the public to attend.

Everyone entering their dogs at these specialty shows and attending the event for any reason is aware of, and accepts, any public health risks that may exist at the time and is fully responsible for the consequences of their own actions. Although the Clubs intend to follow Public Health Guidelines, they accept no responsibility, financial or otherwise, for loss, damage or injury that may occur as a result of anyone's participation of any kind in these shows.

If it should become necessary for the Clubs to cancel these shows for any reason, prior to the closing date for entries, any entry fees received will be refunded in full in a timely manner to the person that made such entries and in the form he or she made them. If the show must be cancelled after close of entries, the Clubs will retain that portion of the entry fees that are needed to offset unavoidable costs of the show and intends to refund the balance. Any fees charged for on-line entry are not refundable.

From Hwy 99, take Kettleman/Highway 12 exit. Proceed through Lodi. From the last traffic light (Lower Sacramento Road), it is 3.5 miles to Ray Road. Take a right on Ray Road and go almost 1 mile to the first curve. At the curve, take a left on to Sargent Road and follow the signs to Sycamore Lane Kennels and the site of the specialty.
